22. Line 327-328

Change to: "The Student Council will furthermore push RUC to do the same, demanding skill development and educational opportunities for the Student Council, rus-chairpersonship, and tutors in regard to tutoring." Motivation: Again, the rus-chairs and RUSKs are together "the rus-chairpersonship". The tutors should be included in skill development and educational opportunities. We should include education as gaining new knowledge is equally important.

23. Line 329-330
