	Daniel:
	The government proposal (to shorten the master programmes from 2 to 1 year) will be sent out very soon. On the 28 th of February a meeting will be held in KU's Student House regarding the shortening of the master programmes so everyone is welcome to join this meeting in Copenhagen. There is an identical meeting held in Aarhus the following Monday if you'd rather visit that one.
	There's gonna be a demonstration on Friday around 16 in Copenhagen marking the one year of the Russian invasion of Ukraine in front of the Russian embassy.
	Mads:
	We've had the first AR meeting which went okay. The rectorate is a bit annoyed with the student members already since they've had trouble figuring out the spots in the council and the sub council. If we regain our third mandate at the next election, we won't have to fight about the spots with Frit Forum. The student ambassador from KU has been invited for the next meeting to talk about what their role has been at KU so that it might be implemented at RUC.
	Jannick:
	On the 2 nd of March, there will be held a debate by the Radical Left (Radikale Venstre) with a bunch of their politicians and then the national representative from Frit Forum as well as Daniel who is our vicechairperson. The debate revolves around the government's proposal to shorten the master programmes. Daniel is open for suggestions on what he should speak about during the debate.

	Our new student employee, Jessie, has been hired and started working from February. She is very open to help you out with your work etc.
#3:	Proposed amendments to the bylaws /16.35-17.20
	§ 13 – stk. 1 punkt 2 : APPROVED (17 voted yes, no one against)
	For future reference; present the point which the mentioned point should align with
	§ 13 – stk. 7 : APPROVED (17 voted yes, no one against)
	Creation of a new point : NOT APPROVED (6 against, 11 blank)
	Question; shouldn't there be another Extraordinary General Assembly for an alternate to become a part of the Board?
	Answer; yes, there will have to be another Extraordinary Assembly since an alternate can't join the Board unless a current Board member leaves or applies for time off (leave).
	Question; What is the motivation behind this? It seems risky since there might be a big gap between what happens in University Politics for the UNIPOL coordinator vs. the Board
	Note; It should be definitely considered again at the next General Assembly if it doesn't get voted in now since we have presented with the idea at this point which can foster further debate later on.

	The changed amendment; (17 yes) APPROVED
	Amendment change should also include "Forpersonskabet samt fire/fem medlemmer fra bestyrelsen"
	We should write it out instead of doing a slash since it should be explained how many spots are available for normal EC members if we don't have three people in the chairpersonship. This should be explained clearly in the bylaws.
	The amendment has been rewritten to give a clearer explanation of the change in members of the EC;
